Proceedings of the 2005 Annual Directors Meeting at Salado (TX)

I. Opening

The meeting was opened at 8:00 p.m. on Friday, 11 November 2005, by Vice President William J. Wallace. A quorum was declared. Tom E.S. Wallace gave his proxy to Marcus Wallace and John Wallace gave his proxy to Wayne Jones.

II. Reading of the 2004 Minutes

The <u>Minutes of the 2004 Annual Meeting</u> were approved as reviewed by the Board following the 2004 meeting.

III. Treasurer's 2005 Financial Report

The 2005 treasurer's financial report was presented and approved. It was for the year ending 30 September 2005. It was noted that several bills were yet to be paid for the year. It was moved, seconded, and passed to accept treasurer's report as presented.

IV. Committee Reports

The Election and Ballot Committee report was prepared by James Schmelzer and provided by John Wallace. There were four openings on the board and five council members were nominated. The election of board members was held and the following were elected: Charles M Wallace, Jean Wallace, Marcus James Wallace and James L. Wallace. There was also a change to the By-laws, which required a vote. Seventy-six Council Members voted, and the By-laws were passed with 72 in favor, 3 against, and 1 abstention.

The Membership Committee Report was provided by Richard A. Wallace. He reported that between 01 October 2004 to 05 October 2005 there were 125 new members with 31 of them council members. The state with the most new members was California with nineteen. Arizona had fifteen and Texas had nine. Report was approved.

The Newsletter Editor and Manager Report was given by Elmer Inman. Tom Wallace and Marcus Wallace serve as Co-Editors. Elmer gave a report combining the Editor and Manager report. There are 445 news letters sent by bulk mail and about 10 are sent first class. To date in 2005 there have been three newsletters plus a special edition devoted to the trip to Scotland.

The <u>Convenor Affairs Report</u> was given by Jean Robinson Wallace. She reports a problem of having convenors' email addresses reject attachments. Keeping a current list is a continuing problem.

Kay Cayler, Secretary, reported that the Society had sold all of the books by Phelps. She had discovered that all of the Society's books were available on the Internet. She recommended that the Society get out of the business of reprinting some books and, instead, direct folks to various web sites where books with Wallace information might be found. It was moved and seconded not to reprint more books and to give the President the authority

to pursue commercial publication and include a link to publications on our website. The board voted to approve the motion.

V. Other Reports

Marcus Wallace reported on document and publication translation. Maitland papers are being translated by a person who reads and translates Latin. This person has had serious medical problems and has very limited eyesight. These papers have Wallace information. Hopefully, this translation will be done within the next couple of years. It was suggested that Higginson should also be contacted about possible the initial printing.

William Wallace and Wayne Jones gave a brief report on the new Rewards Program. This program is growing rapidly and has generated a significant amount of income.

VI. Unfinished Business from 2004

It was moved, seconded and approved to verify and ratify CWSW business conducted by email, phone, etc., since the 2004 ADM. A copy is attached.

JoAnne McIntosh reported that a revised copy of the Society's Articles of Incorporation would be submitted to the Texas Secretary of State by their effective date of 1 January 2006. This will reflect the changes in the Membership structure.

JoAnne stated that under the "Fair Use Privilege" rules that the Braveheart Poster cannot be used except for educational purposes. It was voted to seek permission from the studio to use it in this manner. JoAnne will write a letter to the studio and perhaps seek assistance from Randall Wallace.

The Society made a £500 donation to the Smith Museum in Stirling in August 2005 and has received a Certificate of Thanks.

It was announced that Presidential Medallions have so far been presented to most known Past Presidents of the Society, as well as to the Chief, Ian Francis Wallace. A Medallion is being prepared for presentation Harry A. Wallace III of West Virginia, who, according to records, served as the second President of the Clan Wallace Society.

During 2005 James Hamilton Wallace resigned his position as Canadian Commissioner. It is anticipated that Tom Wallace will be appointed to a similar position once he steps down as a Board Member.

The Friday meeting closed Sine Die.

I. Opening

The meeting reconvened at 10:15 a.m. on Saturday, 12 November 2005, again with a quorum. All Directors were present except John Wallace and Tom Wallace.

II. Certification of New Directors

Upon opening the meeting, the Board voted to certify the new Directors, which include: Charles M. Wallace of Georgia; James L. Wallace of Maryland; Jean R. Wallace of Arkansas and: Marcus J. Wallace of Texas.

The board voted to appoint Tom Wallace as its first Advisory Director for Canada.

It was voted to donate \$500 US to a Canadian Mural project in Wallaceburg, ON. The mural features and commemorates Sir William Wallace.

It was drawn to the attention of the Board that the Wallace Family in Scotland would not, ever, have used Gaelic as a language. A Scottish Council Member requested that the Society consider removing Gaelic from the masthead of the newsletter. It was agreed that because the CWSW promotes all Scottish heritage, that the Gaelic would be retained.

It was voted to provide 98-year-old Elizabeth Wallace Caseby with a Life Membership in recognition of her dedication to the Clan Wallace and all things Scottish. Council Member Dorothy Knight brought this active Scot to the attention of the Society.

There was a consideration of a Society Historian, but it was tabled to a possible future email discussion for possible Board action.

- IV. The following Directors were nominated for the 2006 Officer Positions: John R. Wallace for President; William J. Wallace for Executive Vice President; Kay F. Cayler for Secretary; and Robert B. Wallace for Treasurer. The Board voted to elect those nominated. Wayne Jones expressed an appreciation to all of the Directors who have agreed to serve for another year to maintain consistency in conducting Society business.
- V. Bill Wallace presented his ideas regarding a possible new position of Society Publicist. It is felt that there needs to be a person who will submit articles to various Scottish publications or local papers where events are being held. There will be a job description created and a request for a person who might be interested in the position, which does not require Director level status.

Dick A. and Jan Wallace are resigning as the Society's Membership Co-Chairs effective 31 December 2005. Charles M. Wallace will be the new Membership Chairman.

Jean Wallace will research the advertising costs in various Scottish Heritage Publications and Papers and will report her findings to the Board by email.

It was voted to have the <u>2006 ADM in Rio Rancho, NM</u>, near Albuquerque in October. The exact dates were uncertain at the time of the meeting, but it is believed that they will be the 14th & 15th. Clan Wallace will meet for a dinner on Friday night so that members may participate in a ceidlih on Saturday night if they wish. Jean will check on rates at the Rio Rancho Best Western.

The 2006 CWSW Budget was presented by Treasurer Bob Wallace. It was moved to accept the budget as amended. The amend-

ment removed \$3000 from Rewards Program expenses. A copy of the revised budget is attached.

VI. Marcus opened discussion about potential <u>Society Projects in Scotland</u>. Two potential Projects were identified:

Repair the exterior wall at the Robroyston Monument, which marks the spot where William Wallace was betrayed and captured. More information will be sought and a decision vote to proceed can be taken via email.

Assist the Renfrewshire Council in a project to preserve and protect the Wallace Yew Tree at the Elderslie Monument site. Information on this project is being prepared and will be the subject of an email discussion and vote later in the year.

VII. Wayne presented the new Membership Chairman Handbook. He discussed the reasons behind the need for this handbook and then reviewed the Handbook for the Board. During the discussions, it was determined that the President would sign a number of Membership Certificates in advance and place them in the hands of the Membership Chair for issue when needed. The Membership Chair is authorized to sign the Annual Membership Certificates. Wayne will make some editorial changes to the Handbook prior to sending it out for final review and approval by the Board.

VIII. Bill Wallace presented a developing mission statement and vision statement for the Society. He is seeking additional input from other Directors as he further develops these statements. Bill presented a discussion of his current duties and suggested other duties (including things he is actually currently involved with) for inclusion in the EVP Job Description. He emphasized that the EVP should be copied on all email correspondence. It was voted to change the scope and approve the proposed new duties for the

Award For Bravery

Council Member Lee Foster of Marysville, CA, was honored recently by the Yuba County Sheriff's Department with an Honorary Certificate of Bravery for saving two children from drowning in the Yuba River, near Lee's home.

The children and their father went over a dam on a small rubber raft. None wore life jackets. It was early spring and the river was running high, cold and swift. They had no idea the dam was ahead of them. Lee was in the area on a wave runner watercraft and heard one of the boys scream for help. At great peril to himself, Lee went up to the base of the dam and rescued the first child, aged 10, who was being sucked under into the whirlpool. The force of the water was so great that the child was stripped of his clothes. Lee then picked up the other child, and brought both to safety. Tragically, the boys' father drowned and his body was recovered down river several days later. Lee is the grandson of Richard and Jan Wallace, also of Marysville.

Missouri School Outlaws Wallace Tartan Kilt

JACKSON, MO - Nathan Warmack wanted to honor his heritage by wearing a Scottish kilt to his high school dance. Then a principal told him to change into a pair of pants. What began with a few yards of tartan has sparked an interna-

tional debate about freedom, symbols and cultural dress. More than 11,985 people have signed an Internet petition seeking an apology for the high school senior.

Interested and supportive Scots across the United States are assembling a traditional ensemble they hope the student will wear to the prom, and his family is trying to change the school's dress code policy. "It's a kilt. It's going to turn heads, but I never believed it would have become what it is." Mr. Warmack said.

Other schools around the country also have wrestled with the issue. A principal in

Victoria, Texas, ordered two boys into "more appropriate" attire when they wore kilts to school in 1992, saying: "I know kilts. Those weren't kilts and the boys aren't Scots." In 1993, a student in Fayette County, GA, was not allowed to enter his prom at McIntosh High School because he showed up in a kilt and refused to change clothes.

And while they weren't trying to dress in kilts, a few boys were allowed to wear skirts to class at Franklin Community High School in Indiana in 1997, when a superintendent said different people express themselves in different ways. Mr. Warmack, a defensive lineman on the football team, lives in Jackson, a growing, largely middle-class city of about 14,000 people about 100 miles southeast of St. Louis. He became interested in his family's Scottish ties after seeing Mel Gibson's 1995 movie Braveheart, about William Wallace's battle to overthrow English rule in 13th century Scotland. Nathan reads books about Scotland and visits websites to learn more about his family's genealogy.

He bought a kilt off the Internet to wear to his school's formal dance in November. Mr. Warmack said he showed it to a vice-principal before the dance, who joked he'd better wear something underneath it, and Mr. Warmack assured him he would. Nathan's parents, Terry and Paula, helped him piece together the rest of his outfit, a white shirt and black tie with

white socks and black boots. "We wanted it to be acceptable for the occasion," Terry Warmack said.

After Nathan Warmack and his date posed for pictures, Principal Rick McClard, who had not previously seen the kilt, told the student he had to go change. Mr. Warmack refused a few times and said the outfit was recognizing his heritage. Mr. Warmack alleges Mr. McClard told him: "Well, this is my dance, and I'm not going to have students coming into it looking like clowns." Mr. McClard later said he had no recollection of saying that, Mr. Warmack's dad said. The principal did not return phone calls seeking

comment.

Several Scottish heritage organizations are angry, saying the kilt is a symbol of Scottish pride and considered formal dress. "To say the traditional Scottish dress makes you look like a clown is a direct insult to people of Scottish heritage and those who live in Scotland," said Tom Wilson, a Texas commissioner for the Clan Gunn Society of North America, a Scottish heritage organization. It questions in part the notion that the kilt was a distraction. "From what? From the intense concentration it takes to dance?" Scottish groups are hoping they can help him to establish a formal Scottish ensemble that more fully reflects his heritage, including pieces that are being handmade for Nathan Warmack.

Board Appointment

William Wallace's "Other" Sword: The Lost Loudoun Sword

Mr. John G. McGill, FSAScot, resident of Riccarton, Scotland, has located a priceless piece of Scotland's heritage: a long missing sword that belonged to Sir William Wallace.

"It is the Loudoun Wallace Sword which was a gift from the Hanseatic League in Lubeck to Wallace, as a symbol of his authority. After Sir William Wallace's execution 701 years ago, tradition has it that his sword passed to Wallace's mother, Lady Margaret Crauford Wallace. From her, the sword passed down through many generations and into the 20th century, being kept all this time at Loudoun Castle, near Galston.

In 1930 the Loudoun Wallace Sword was sold to J.H. Watson of Grangehill, Beith. Although the family no longer live in Ayrshire, the sword is still in Scotland in the ownership of the buyer's family. It is believed that the family are considering the best future for the sword. Says Mr. McGill: The importance of this item to Scotland as a nation cannot be over stressed. It has no blood on it. It was never a weapon of war. It was a symbol of Scotland's independence and of the authority of Scotland's leaders and their faith in electing Sir William Wallace as Guardian of Scotland."

John explained the origins of the sword; "When he was appointed as Guardian of Scotland, Sir William Wallace went to Europe to reacquaint the Hanseatic League, the equivalent of the EEC in it's day, with Scotland as a trading nation, free again to do business. He carried with him a letter which he pre-

sented to the League, the so called Lubeck letter. "The Burgermeisters representing the Hanseatic League presented Sir William Wallace with a magnificent ceremonial sword which was a symbol of independence and authority."

"It is a great pity that the sword is not better known and that it has been hidden from the public for so long. "In the past 700 years it has only made three public appearances." The first was in 1822 during the only visit to Scotland by King George IV. The second appearance was in 1930 when it was put up for sale. The third was in 1972 after someone stole the better-known Wallace sword from the monument in Stirling.

"An enterprising national newspaper tracked down the owner of the Loudoun Wallace Sword for a publicity feature in the hope that the stolen one would turn up. "Although hidden all these years there is a tremendous interest in this sword and of course in Wallace."

"I have no influence on any decision by the present owners, but if it is to be put on display, even on a 'temporary loan' I can think of only one place where such an important relic should go on display. After all, it is a symbol of authority and of our nationhood."

Mr. McGill, who is also published under the nom de plume "Craufuird C. Loudoun," assures that the Wallace Loudoun Sword is still in Scotland and while he cannot reveal its exact location, he hopes that the current owners will put it on public display. When questioned about the number of Wallace swords in existence and he believes there are possibly four. The one in the archives at the Wallace Monument, the replica on display at the Wallace Monument which was created after the original was stolen in 1972, the current Loudoun Sword, and a possible fourth in the Wallace Collection in London.

Andrew Wallace, a veteran of the War of 1812. Making overtures to the past is something of an obsession for Devore, Col. Wallace's great-granddaughter. A kilted bagpiper led the procession to the grave of Col. Wallace, who hailed from the Ireland, and a marker was unveiled honoring his service to his country in the second (and less well-remembered) war with Britain.

A retired teacher, she does her genealogical homework so thoroughly because she says you can't truly know who you are until you understand the ancestral genes that

gave you that grin, those eyes, this way of walking, that attitude. "Wallace lived a good life, fought for his country and he was a good husband and father, a farmer who lived to be 87 and outlived all but two of his 11 children," says Devore, who speaks like she met him. "I don't want him to be forgotten."

Even the food served following the service was selected to speak to aspects of Col. Wallace's life. Guests dined on "Irish Rolled Steak," "Potatoes Presbyterian," "Ulster Scones" and "Pro-Libertate Cake." There also was a "Methodist Salad," as "some of Wallace's descendants ended up going that route." All in all, "I wanted to make people want to be there," says Marjorie. "I wanted to make it special."

Sir William Wallace Named "Greatest-Ever Scot!"



Sir William Wallace was recently voted Greatest-Ever Scot by readers of "Scotland On Sunday." He prevailed over Robert Burns, Flora MacDonald, Robert the Bruce, Sir Sanford Fleming and Adam Smith.

William Wallace was the Scottish patriot whose bloody death culminated in his limbs being sent to the four corners of Britain as a warning to all who followed him. But, just as Edward Longshanks failed to quell the rebellion that led to Scottish independence, William Wallace's legacy lives on. The guerrila fighter is today named as the Greatest Ever Scot in a popular poll staged by the ezine "Scotland on Sunday" readers.

Following two weeks of online voting, Wallace secured more than a third (35%) of 1,300 votes in the "Scotland on Sunday" poll.

The warrior, who was executed in London in 1305, was a clear winner ahead of the poet, Robert Burns, who had shut-out Wallace Wallace in an exclusive poll of academics and historians. The Bard, who gained 24% of the vote, proved significantly more popular than Wallace's fellow combatant, Robert the Bruce, who polled 15%.


Sir Alexander Fleming, who discovered penicillin, came fourth, with 8.5%.

The voting also saw 50 alternative Great Scots nominated by our readers, including physicist James Clerk Maxwell, the father of television, John Logie Baird, and engineer Thomas Telford. Profes-

sor Richard Finlay, director of the Research Centre in Scottish History at the University of Strathclyde, said, "Wallace has always been popular, throughout the 19th and early 20th century, and it will always be difficult to overturn a national icon of that stature. Mel Gibson's portrayal of him has brought Wallace to a new generation and the votes seem to confirm that people believe what they see in the movies."

The public vote saw a clear gap between Wallace, Burns and Bruce and the other seven contenders, who included Sir Walter Scott, David Livingstone, Andrew Carnegie and Alexander Fleming.

However, Michael Fry, the author of Wild Scots: 400 Years of Highland History, was "dismayed" that Wallace had outpolled his fellow freefighter. dom Robert Bruce. Frv said: "It is regrettable but typical that

Scotland should choose a loser, albeit a glorious one, as its hero. One hundred years ago, Scots admired success but now they admire failure: just look at our national football team. "The great irony is that it was Bruce who saved the nation. The fact that his contemporary is much more admired is dismaying."

Philosophers and scientists were prominent on the shortlist. However, Adam Smith, the Kirkcaldy-born economist famed for his *Wealth of Nations*, and David Hume, his contemporary in the Scottish Enlightenment, failed to convert academic admiration into popular votes. They were in fifth and sixth places respectively in the poll, scoring 5.5% and 4%.

Finlay added: "What can be said about Hume and Smith is that they were very influential as Scots, but there was nothing in their writings that was particularly Scottish. Burns, however, who got more votes, had a Scottish hallmark in his work. The fact that he has an annual celebration named in his honour helps him retain his reputation for all time."

James Clerk Maxwell, who narrowly failed to make it on to Scotland on Sunday's 10 Greatest Scots shortlist, chosen by the academic panel, was the most popular alternative among readers, securing 17% of the other votes.

Professor Tom Devine, holder of the Sir William Fraser Chair of Scottish History at Edinburgh University, whose personal nominations included Clerk Maxwell, said: "He was an outstanding physicist whose theories were later cited by Einstein as being pivotal to his work.

"Any survey of the Greatest Scots would be the poorer without at least mentioning Clerk Maxwell."

The few women nominated by readers included Elsie Inglis, who defied the War Office to establish field hospitals in France, Serbia and Corsica during the First World War, Flora MacDonald, who helped Bonnie Prince Charlie flee to France after defeat at the Battle of Culloden in 1746, and Mary Slessor, a 19th century missionary in Nigeria.

However, none received enough votes to make it into the Top Ten.

Modern-day Scots who received nominations from readers included footballer Kenny Dalglish, Eurythmics singer Annie Lennox, and former racing driver Sir Jackie Stewart.

Regardless, they were trounced by the numbers who pledged their support (and their vote) to William Wallace.
